The **Zenith Award** was **established in 1990** by the Sidney-Shelby County Chamber of Commerce to honor Shelby County community leaders whose *lifetime* of community service has had a profound impact on the quality of life in Shelby County.

CIVIC PARTICIPATION

PHILANTHROPY (Time, Treasure, and/or Talent)

Nominees need not have experience in each category.

The Chamber of Commerce accepts nominations for the Zenith Award at any time during the year. Nominations, once submitted, will be maintained on file at the Chamber of Commerce office and need not be submitted each year. Nominations may be updated if necessary.

A selection committee comprised of Chamber of Commerce Board members and past Zenith Award Recipients shall meet each year to select a nominee for the Zenith Award. Nominees will be presented to the Chamber Board of Directors for their endorsement. The Board of Directors shall select the final recipient. The award will be presented at the **Chamber of Commerce Annual Dinner**.

The selection committee shall utilize the aforementioned criteria as a basic guideline for selection. However, the committee shall have the freedom to consider other factors that are believed to be relevant to the intent and spirit of the Zenith Award.

All deliberations of the Zenith Award Selection Committee and Board of Directors shall be strictly confidential.
